RULES FOR ALL RENTALS

1. Chaperones must accompany all youth groups. Children 12 years of age and younger must have 1 adult for every 15 children. Children 13 thru 17 must have 1 adult for every 20 participants.
2. **NO** alcoholic beverages, tobacco products or firearms are allowed on YMCA property. Food and drink are allowed in the Event Center and the Activity Room **ONLY**.
3. YMCA facilities are to be used by the group renting the area and will not be open to the general public.
4. **THERE MUST BE ONE (1) ADULT IN THE POOL FOR EVERY 2 CHILDREN UNDER THE AGE OF 8 YEARS OLD. EACH ADULT IN THE WATER MUST BE WITHIN ARMS LENGTH OF 2 CHILDREN.** () APPLICANT MUST INITIAL
5. All swimmers may be asked to complete a swim test to demonstrate water proficiency. () APPLICANT MUST INITIAL
